Start treatment by placing 2 tablets per one ton of air conditioning into A/C drain pan. Add 2 additional tablets per one ton of air conditioning every three months or whenever odor occurs. Hydrex™ may be more effective if the pan or reservoir is drained and cleaned before treatment.
