Alternatively, and at its option, the Company will provide a credit in the amount of the then factory selling price for a new equivalent part toward the retail purchase price of a new Company product. Except as otherwise stated herein, those are Company's exclusive obligations under this warranty for a product failure. This limited warranty is subject to all provisions, conditions, limitations and exclusions listed below and on the reverse (if any) of this document.

RESIDENTIAL APPLICATIONS

- To obtain the longer warranty period as shown in the table under original owner, the product <u>must</u> be properly registered at <u>www.mycorhome.com</u> within ninety (90) days of original purchase. - 2. Where a product is installed in a newly constructed home, the date of purchase is the date the homeowner purchased the home from the builder.
- 3. If the date of original purchase cannot be verified, then the warranty period begins ninety (90) days from the date of product manufacture (as indicated by the model and serial number). Proof of purchase may be required at time of service.
- 4. The limited parts warranty period as shown in the table under subsequent owners does not require registration.
- 5. The warranty applies only to products remaining in their original installation location.
- 6. Installation, use, care, and maintenance must be normal and in accordance with instructions contained in the Installation Instructions, Owner's Manual and Company's service information.
- 7. Defective parts must be returned to the distributor through a registered servicing dealer for credit.
